


WHO IS IN CHARGE AROUND HERE?

PERCEPTIONS OF MARINE GOVERNANCE IN NORTH DEVON.





STATS AND FACTS

The WWF-led UK SEAS project, which is part of the North Devon Marine Pioneer, is looking at how we can help improve marine governance.

On the 3rd February 2018, 49 members of the North Devon Pioneer Marine Working Group were split into three groups, and each group created a map depicting marine governance in North Devon. Marine governance is the rules, institutions, processes, agreements, arrangements and activities used to manage the sea. Participants were asked to identify all the organisations and groups involved, and show how powerful they believed them to be by placing them on a 'circle of influence', where the most influential were at the centre.



143 organisations and groups were identified as playing a role in marine governance in North Devon. This diversity brings both opportunities, in the form of lots of interested and motivated people, but also challenges for coordination and communication.



40 organisations were perceived as being particularly powerful or influential (placed at the centre of the maps). Again, this is a lot of organisations thought to be involved in decision-making.



The majority of organisations perceived as powerful in North Devon were national organisations rather than North Devon-based.



Surprisingly, of the 40 organisations perceived as powerful / influential, only two, the Marine Management Organisation (MMO) and the Devon and Severn IFCA appeared on all three maps, indicating a striking lack of consensus / confusion about who is in charge.

39 organisations were identified as 'unconnected' from the Pioneer Marine Working Group network, including the Crown Estate and some recreational user groups. This is useful information to guide future engagement efforts.







Participants were asked, "On a scale of 1-10, where 10 is the most, do you feel like you have meaningful input into marine management decisions?" The most popular score was 4/10. People have input but limited influence over resulting decisions.



Over 30 marine related initiatives involving local interest groups have taken place in North Devon over the last 15 years including: Finding Sanctuary, VALMER, shoreline management planning, Taw-Torridge Estuary plans and the Atlantic Array consultation.




OPPORTUNITIES
